Description

The ERCW003A6R ORCA™ series of dc-dc converters are a new generation of isolated, very high efficiency DC/DC power modules providing up to up to 3.6A_{dc} output current at a nominal output voltage of 28V_{dc} in an industry standard, DOSA compliant 1/8 brick size footprint, which makes it an ideal choice for high voltage and high power applications. The ERCW003A6R modules have typical efficiency of 93% at full-load and nominal output voltage of 28V. The maximum output ripple of the module is 20mV_{rms}, which helps to reduce external filtering capacitors and system cost. Threaded -through holes are provided to allow easy mounting or addition of a heat

sink for high temperature applications. The output is fully isolated from the input, allowing versatile polarity configurations and grounding connections.

CAUTION: This power module is not internally fused. An input line fuse must always be used.

This power module can be used in a wide variety of applications, ranging from simple standalone operation to being part of complex power architecture. To preserve maximum flexibility, internal fusing is not included; however, to achieve maximum safety and system protection, always use an input line fuse. The safety agencies require a fast-acting fuse with a maximum rating of 10A (see Safety Considerations section). Based on the information provided in this data sheet on inrush energy and maximum dc input current, the same type of fuse with a lower rating can be used. Refer to the fuse manufacturer's data sheet for further information.






Characteristic Curves




Figure 3. Dynamic Load Change Transient Response from 25% to 50% to 25% of Full Load at Room Temperature and 48 V_{in;} 0.1A/uS, $C_{o,ext}$ = 220µF.






Figure 4. Typical Start-Up Using Remote On/Off; C_{o,ext} = 220µF

Figure 5. Typical Start-Up from V_{IN}, on/off enabled prior to V_{IN} step; C_{0,ext} = 220 μ F.










Figure 7. Input Reflected Ripple Current Test Setup.

Test Configurations

NOTE: Measure input reflected ripple current with a simulated source inductance (L_{TEST}) of 12µH. Capacitor CS offsets possible battery impedance. Measure current as shown above.




Figure 8. Output Ripple and Noise Test Setup.

Note: Use a C_{out} (470 μ F Low ESR aluminum or tantalum capacitor typical), a 0.1 μ F ceramic capacitor and a 10 μ F ceramic capacitor, and Scope measurement should be made using a BNC socket. Position the load between 51 mm and 76 mm (2 in. and 3 in.) from the module.




Figure 9. Output Voltage and Efficiency Test Setup.

Design Considerations

Input Source Impedance

The power module should be connected to a low ac - impedance source. A highly inductive source impedance can affect the stability of the power module. For the test configuration in Figure 7, a 150 μ F Low ESR aluminum capacitor, C_{IN}, mounted close to the power module helps ensure the stability of the unit. Consult the factory for further application guidelines.

Output Capacitance

The ERCW003A6R power module requires a minimum output capacitance of 220µF Low ESR aluminum capacitor, Cout to ensure stable operation over the full range of load and line conditions, see Figure 8. If the ambient temperature is under -20°C, it is required to use at least 3 pcs of minimum capacitors in parallel. In general, the process of determining the acceptable values of output capacitance and ESR is complex and is load -dependent.

Safety Considerations

For safety agency approval the power module must be installed in compliance with the spacing and separation requirements of the end-use safety agency standards, i.e., UL ANSI/UL* 62368-1 and CAN/CSA+ C22.2 No. 62368-1 Recognized, DIN VDE 0868-1/A11:2017 (EN62368-1:2014/A11:2017)

For end products connected to -48V dc, or -60Vdc nominal DC MAINS (i.e. central office dc battery plant), no further fault testing is required. *Note: -60V dc nominal battery plants are not available in the U.S. or Canada.

For all input voltages, other than DC MAINS, where the input voltage is less than 60V dc, if the input meets all of the requirements for SELV/ES1, then:

• The output may be considered SELV/ESI. Output voltages will remain within SELV limits even with internally - generated non-SELV voltages. Single component failure and fault tests were performed in the power converters.



 One pole of the input and one pole of the output are to be grounded, or both circuits are to be kept floating, to maintain the output voltage to ground voltage within ELV or SELV/ESI limits. However, SELV/ESI will not be maintained if V₁(+) and V₀(+) are grounded simultaneously.

Safety Considerations (Continued)

If the input source is non-SELV (ELV or a hazardous voltage greater than 60 Vdc and less than or equal to $75V_{dc}$), for the module's output to be considered as meeting the requirements for safety extra-low voltage (SELV) or ES1, all of the following must be true:

- The input source is to be provided with reinforced insulation from any hazardous voltage, including the acmains.
- One V_{IN} pin and one V₀ pin are to be reliably earthed, orboth the input and output pins are to be kept floating.
- Another SELV or ESI reliability test is conducted on the whole system (combination of supply source and subject module), as required by the safety agencies, to verify thatunder a single fault, hazardous voltages do not appear at the module's output.

All flammable materials used in the manufacturing of these modules are rated 94V-0, or tested to the UL60950 A.2 for reduced thickness.

The input to these units is to be provided with a maximum 10A fast-acting or time-delay fuse in the ungrounded input connection.

Feature Descriptions

Remote On/Off

Two remote on/off options are available. Positive logic turns the module on during a logic high voltage on the ON/OFF pin, and off during a logic low. Negative logic remote On/Off, device code suffix "1", turns the module off during a logic high and on during a logic low.




Figure 10. Circuit configuration for using Remote On/Off Implementation.

To turn the power module on and off, the user must supply a switch (open collector or equivalent) to control the voltage (V_{on/off}) between the ON/OFF terminal and the V_{IN}(-) terminal (see Figure 10). Logic low is $OV \leq V_{on/off} \leq 1.2V$. The maximum I_{on/off} during a logic low is 1mA, the switch should be maintain a logic low level whilst sinking this current.

During a logic high, the typical maximum Von/off generated by the module is 5V, and the maximum allowable leakage current at $V_{on/off}$ = 5V is 50µA.

If not using the remote on/off feature:

For positive logic, leave the ON/OFF pin open.

For negative logic, short the ON/OFF pin to $V_{\text{IN}}(\text{-}).$

Overcurrent Protection

To provide protection in a fault output overload condition, the module is equipped with internal current limiting protection circuitry, and can endure continuous overcurrent by providing constant current output, for up to 4 seconds, as long as the output voltage is greater than $V_{trimMIN}$. If the load resistance is too low to support $V_{trimMIN}$ in an overcurrent condition or a short circuit load condition exists, the module will shut down immediately.

A auto-restart option is standard. Following shutdown, the module will restart after a period of 3 seconds if the shutdown happens due to overcurrent protection being triggered or the module will restart after a period of 2.5 seconds when the shutdown happens due to output over-voltage protection getting enabled. An latching shutdown option (4) is also available in a case where an auto recovery is required. If overcurrent greater than 4A persists for few milli-seconds, the module will shut down and auto restart until the fault condition is corrected. If the output overload condition still exists when the module restarts, it will shut down again. This operation will continue indefinitely, until the overcurrent condition is corrected.



Feature Descriptions (continued)

Over Voltage Protection

The output overvoltage protection consists of circuitry that monitors the voltage on the output terminals. If the voltage on the output terminals exceeds the over voltage protection threshold, then the module will shutdown and latch off. The overvoltage latch is reset by either cycling the input power for one second or by toggling the on/off signal for one second. The protection mechanism is such that the unit can continue in this condition until the fault is cleared.

An auto-restart option (4) is also available in a case where an auto recovery is required.

Remote sense




Figure 11. Effective Circuit Configuration for Single-Module Remote-Sense Operation Output Voltage.

Remote sense minimizes the effects of distribution losses by regulating the voltage at the remote-sense connections (see Figure 11). For No Trim or Trim down application, the voltage between the remote -sense pins and the output terminals must not exceed the output voltage sense range given in the Feature Specifications table i.e.:

 $[V_{\text{O}}(\text{+})\text{-}V_{\text{O}}(\text{-})] - [\text{SENSE}(\text{+}) - \text{SENSE}(\text{-})] \leq 2\% \text{ of } V_{\text{o},\text{nom}}$

The voltage between the V_o(+) and V_o(-) terminals must not exceed the minimum output overvoltage shut-down value indicated in the Feature Specifications table. This limit includes any increase in voltage due to remote-sense compensation and output voltage set-point adjustment (trim). See Figure 11. If not using the remote-sense feature to regulate the output at the point of load, then connect SENSE(+) to V_o(+) and SENSE(-) to V_o(-) at the module.

Although the output voltage can be increased by both the remote sense and by the trim, the maximum increase for the output voltage is not the sum of both. The maximum increase is the larger of either the remote sense or the trim. The amount of power delivered by the module is defined as the voltage at the output terminals multiplied by the output current. When using remote sense and trim: the output voltage of the module can be increased, which at the same output current would increase the power output of the module. Care should be taken to ensure that the maximum output power of the module remains at or below the maximum rated power.

Output Voltage Programming




Figure12. Output Voltage Trim Limits vs. Input Voltage.

Trimming allows the user to increase or decrease the output voltage set point of a module. Trimming down is accomplished by connecting an external resistor between the TRIM pin and the SENSE(-) pin. Trimming up is accomplished by connecting external resistor between the SENSE(+) pin and TRIM pin. The trim resistor should be positioned close to the module. Certain restrictions apply to the input voltage lower limit when trimming the output voltage to the maximum. See Figure 12 for the allowed input to output range when using trim. If not using the trim down feature, leave the TRIM pin open.

Trim Down – Decrease Output Voltage




Figure 13. Circuit Configuration to Decrease Output Voltage.

With an external resistor (R_{adj_down}) between the TRIM and SENSE (-) pins, the output voltage set point ($V_{O,adj}$) decreases (see Figure 13). The following equation determines the required external-resistor value to obtain a percentage output voltage change of Δ %.

$$R_{adj_down} = \begin{bmatrix} 511 \\ \Delta\% \end{bmatrix} - 10.22 k\Omega$$

Trim Up – Increase Output Voltage




Figure 14. Circuit Configuration to Increase Output Voltage.

With an external resistor (R_{adj_up}) connected between the SENSE(+) and TRIM pins, the output voltage set point ($V_{o,adj}$) increases (see Figure 14).

The following equation determines the required external-resistor value to obtain a percentage output voltage change of Δ %.

The voltage between the $V_o(+)$ and $V_o(-)$ terminals must not exceed the minimum output overvoltage shut-down value indicated in the Feature Specifications table. This limit includes any increase in voltage due to remote- sense compensation and output voltage set-point adjustment (trim). See Figure 11.

Although the output voltage can be increased by both the remote sense and by the trim, the maximum increase for the output voltage is not the sum of both. The maximum increase is the larger of either the remote sense or the trim. The amount of power delivered by the module is defined as the voltage at the output terminals multiplied by the output current. When using remote sense and trim, the output voltage of the module can be increased, which the same output current would increase the power output of the module.

Care should be taken to ensure that the maximum output power of the module remains at or below the maximum rated power.

Examples:

To trim down the output of a nominal 28V module to 16.8V



Active Voltage Programming




Figure 15. Circuit Configuration to Actively Adjust the Output Voltage.

For ERCW003A6Rx, a Digital-Analog converter (DAC), capable of both sourcing and sinking current, can be used to actively set the output voltage, as shown in Figure 15. The value of RG will be dependent on the voltage step and range of the DAC and the desired values for trim-up and trim-down Δ %. Please contact your OmniOn Power technical representative to obtain more details on the selection for this resistor.




Figure 16. AC-DC Load Profile

The ERCW003A6Rx is compatible with load profiles as shown in Figure 16.

The output voltage peak deviation shall not exceed the peak values listed in the Electrical Specifications Table.

Over Temperature Protection

The ERCW003A6R module provides a non-latching over temperature protection. A temperature sensor monitors the operating temperature of the converter. If the reference temperature, T_{REFI} , exceeds a threshold of 135°C (typical) for open frame version, and 120°C for base plate version. The converter will shut down and disable the output. When the base plate temperature has decreased by approximately 20°C the converter will automatically restart.

Thermal Considerations




Figure 17. Case (T_{REF}) Temperature Measurement Location (top view).





Figure 18. Case (T_{REF}) Temperature Measurement Location (top view).

The power modules operate in a variety of thermal environments; however, sufficient cooling should be provided to help ensure reliable operation of the unit. Heat-dissipating components inside the unit are thermally coupled to the case. Heat is removed by conduction, convection, and radiation to the surrounding environment. Proper cooling can be verified by measuring the case temperature. Peak temperature (T_{REF}) occurs at the position indicated in Figure 17 and 18.

Considerations include ambient temperature, airflow, module power dissipation, and the need for increased reliability. A reduction in the operating temperature of the module will result in an increase in reliability. The thermal data presented here is based on physical measurements taken in a wind tunnel.



Thermal Consideration (continued)

The output power of the module should not exceed the rated power for the module as listed in the ordering Information table. Although the maximum TREF temperature of the power modules is discussed above, you can limit this temperature to a lower value for extremely high reliability.

The thermal reference points, T_{ref} , used in the specifications for open frame module is shown in Figure 17. For reliable operation, the temperatures should not exceed 122°C.

The thermal reference points, $T_{ref,}$ used in the specifications for base plate module is shown in Figure 18. For reliable operation, the temperature should not exceed 113°C.

Thermal Derating





Figure 20. Derating Output Current vs. Cold Wall Temperature with local ambient temperature around module at 85C; V_{in} =48V




Figure 22. Derating Output Current vs. local Ambient temperature and Airflow, with Baseplate, Vin=48V, airflow from Vi(-) to Vi(+).

Thermal derating is presented for two different applications: 1) Figure 19 and 20, the ERCW003A6R module is thermally coupled to a cold plate inside a sealed clamshell chassis, without any internal air circulation; and 2) Figure 21, the ERCW003A6R module is mounted in a traditional open chassis or cards with forced air flow. In application 1, the module is cooled entirely by conduction of heat from the module primarily through the top surface to a cold plate, with some conduction through the module's pins to the power layers in the system board and can deliver full load upto 100°C. For application 2, the module is cooled by heat removal into a forced airflow that passes through the interior of the module and over the top base plate and/or attached heatsink. Figure 22 shows thermal derating curves for ERCW003A6R module with baseplate attached.

Layout Considerations

The ERCW003A6R power module series are constructed using a single PWB with integral base plate; as such, component clearance between the bottom of the power module and the mounting (Host) board is limited. Avoid placing copper areas on the outer layer directly underneath the power module.

Post Solder Cleaning and Drying Considerations

Post solder cleaning is usually the final circuit-board assembly process prior to electrical board testing. The result of inadequate cleaning and drying can affect both the reliability of a power module and the testability of the finished circuit-board assembly. For guidance on appropriate soldering, cleaning and drying procedures, refer to OmniOn Power Board Mounted Power Modules: Soldering and Cleaning Application Note.

Through-Hole Lead-Free Soldering Information

The RoHS-compliant through-hole products use the SAC (Sn/Ag/Cu) Pb-free solder and RoHS-compliant components. They are designed to be processed through single or dual wave soldering machines. The pins have an RoHS-compliant finish that is compatible with both Pb and Pb-free wave soldering processes. A maximum preheat rate of 3°C/s is suggested. The wave preheat process should be such that the temperature of the power module board is kept below 210°C. For Pb solder, the recommended pot temperature is 260°C, while the Pb-free solder pot is 270°C max. The ERCW003A6R can be processed with paste-through-hole Pb or Pb - free reflow process. If additional information is needed, please consult with your OmniOn Power representative for more details.




Packaging Details

Figure 25. ERCW003A6R Packaging Tray






Mechanical Outline for Through-Hole Module with Heat Plate (-H Option)




Mechanical Outline for Through-Hole Module with ¼ Brick Heat Plate (-18H Option)


